Live Oak School engages Title I parents in meaningful interactions with the school. It supports a partnership among staff, parents, and the community to improve student academic achievement. To help reach these goals, the school does the following: Assists Title I parents in understanding academic content standards, the curriculum, assessments, student proficiency levels, and how to monitor and improve the achievement of their children.

## 2.1 Involvement of Parents in the Title I Program

In August, an evening meeting is held by the Principal and other staff members to inform parents about Title I requirements and parental involvement.

Parent information meetings such as Back to School Night and Parent Teacher Conferences are held in English and Spanish to discuss ways for students to be successful.

Parent meetings and conferences are held throughout the school year and offered on a flexible schedule to assist parents.

Parents were polled at each meeting as to what day and time works the best for them.

The Live Oak Elementary School Parental Involvement Policy and the School-Parent Compact are reviewed annually by the School Site Council, English Language Advisory Committee, and the School Instructional Leadership Team. The Title I program is reviewed as part of the annual review of the SPSA. School Site Council meetings examine and improve the Title I programs offered at Live Oak Elementary. This parent input is vital in revising programs. The School Site Council reviews and approves the school parent and family engagement policy.

Through parent newsletters, Back to School Nights, School Site Council, English Language Advisory Committee and PTA parent meetings inform parents about Title I programs and involvement activities at Live Oak Elementary. These regularly held meetings are in both English and Spanish. The school website is updated with the Family Involvement Policy yearly and Blackboard Connect messages are also sent to parents to highlight important events in both languages

ii. A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging state academic standards. (20 U.S.C. § 6318[c][4][B])

At parent-teacher conferences, assessment information on student academic progress and grade level standards is shared with parents. Student progress in relation to state and local standards will be explained to parents including the curriculum being used, grade-level expectations for proficiency, data reporting for state and local assessments, and available interventions in reading, ELA, and mathematics for students needing assistance. Live Oak uses the district-adopted math, English Language Arts, Science, and Social Studies curriculum. Progress Reports are sent at the midpoint of each quarter to parents. Report Cards are sent during the 3 assessment periods to parents.

iii. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. (20 U.S.C. § 6318[c][4][C])

Parents can provide feedback and input by visiting the school website and contacting the adminstrator to set up a meeting to discuss suggestions for school improvement as well as through formal parent-teacher conferences, informal requests by parent meetings, Back to School Nights, SSC, ELAC and PTA.

## 2.2 Building Capacity for Involvement

The school provides parenting classes and opportunities for supporting their child's education such as Parenting Partners and Jump Into English.

Strategies to enhance parent involvement are discussed and integrated into our educational program at staff meetings and grade-level teacher meetings. Educational programs are communicated to parents through parent newsletters, Back to School Nights, School Site Council, English Language Advisory Committee and PTA meetings.

Live Oak communicates high expectations for every student, motivates all students to learn, teach and involve students in instruction that corresponds to State standards, enforce rules equitably, and communicate regularly with families about their child's progress. The ways in which parents will be responsible for supporting their children's learning includes making efforts to attend school event, parent-teacher conference, PTA meetings, and Back to School Night. Parental participation, as appropriate in decisions relating to the education of their children and positive use of extracurricular time.

Parent teacher conferences occur annually during the first quarter of the school year where students' progress and the parent compact is discussed. Communication between home and school occurs regularly through the school website, monthly newsletters, weekly and daily emails, phone calls, and text messages as appropriate.

Report cards and sent home during the three assessment windows throughout the year.
