- 1. Textbook Selection Recommendation:
 - A. District Textbook Selection Committee Review
 - Committee Review
 - Department Review: All 9-12 Sites
 - Principal Review: All 9-12 Sites
 - Assistant Superintendent of Curriculum and Instruction Review
 - Assistant Superintendent of Secondary Review
 - **B. Site Textbook Committee Review**
 - a. All 9-12 Department reviews and sign
 - b. All 9-12 Principals reviews and sign
- Technology reviews/sign prior to submission required for all textbooks. Submit a Web Help Ticket for review-allow sufficient time for this (2 weeks).
- 3. Curriculum Council Review
 - Textbooks will be available at least one week prior to the Curriculum Council meeting for council members to review.
 - Curriculum Council will hear a report and a recommending vote will be taken.
- 4. Instructional materials will be publicly displayed for two weeks prior to the Board of Education meeting at which the materials will be presented. Each school board member will be provided an opportunity to preview the materials.
- Board of Education Approval Action Item.

Curriculum Council 9-12 Textbook Review Process

- Schedule a date for presenting a textbook to Curriculum Council with the Curriculum and Instruction office.
- 2. The following items must be submitted to the Assistant Superintendent of Curriculum & Instruction at least one week prior to the Curriculum Council Meeting:
 - Completed & signed 9-12 Textbook Selection Forms, including Instructional Materials Review Form.
 - Copy of the grade-level textbook.
- Curriculum Council will hear a report and vote to do one of the following:
 - Recommend approval of the textbook/materials, or
 - Refer back for additional information.
 - o The requested information will be presented for a vote at the next Curriculum Council meeting.

9-12 Textbook Report Format

Presentations to Curriculum Council should be limited to 10 minutes and include:

- An overview of the textbook
- Identification of special features
