Superintendent's Report

Superintendent Young congratulated Nutrition Services for being awarded the Fresh Fruits and Vegetables Grant, stating it provides classroom education and 3-5 tastings per school year for each of the selected school locations. He announced that the 14th Annual College and Career Planning Night will be taking place on August 29, 2023, at Tokay High School from 5:30-7:30 p.m. Mr. Young stated the newly sanctioned Girl's Flag Football has begun and he is excited for the season.

Anne Swehla Garcia, Teacher, Julia Morgan Elementary School, invited Board members to visit Lodi Education Association's public website, which is profiling a "Different Today," and requested teachers receive no-tell days.

Camille Sosa, Student, Lodi High School, spoke about the removal of a pride flag from a classroom.

Andrew Robison, Parent, spoke about his special needs daughter and questioned how the funding is being allocated for special education, noting he would like to see positive changes in the special education department, transportation, and more teachers hired.

Item OAI-4 Proposition 28—The Arts and Music in Schools (AMS) Funding Guarantee and Accountability Act Waiver Request to California Department of Education (CDE)

Robert Sahli, Associate Superintendent, presented Proposition 28, stating that 80% of the funds are allocated for staffing or employee services and 20% are allocated to supplies to support the programs, unless a district has good cause to apply for a waiver. He stated that the district cannot find enough staff and would like to request the waiver to use the remaining funds for supplies.

Item OAI-5 Approval of a Technical Revision to Board Action of April 25, 2023 Increasing Teacher Substitute Budget by 30% to Reflect a 30% Bonus for Teacher Substitutes Based on their Daily Substitute Pay from July 1, 2023 to June 30, 2024

Superintendent Young presented a technical revision of the substitute budget stating that preschool was left off of the previous item.

No public or Board comments were received.

Mrs. Macfarlane moved, Mr. Stroh seconded, and the Board voted to unanimously approve Item OAI-5 Approval of a Technical Revision to Board Action of April 25, 2023 Increasing Teacher Substitute Budget by 30% to Reflect a 30% Bonus for Teacher Substitutes Based on their Daily Substitute Pay from July 1, 2023 to June 30, 2024.

COLA/New Cash Calculation

Leonard Kahn, Chief Business Officer, gave a report on state funding relative to cost-of-living adjustment (COLA) and Lodi USD declining average daily attendance (ADA). He stated the effect of declining enrollment on the 2023/2024 school year budget versus the stated COLA of 8.22%, results in roughly \$12.972 million in new cash, which is approximately 4.99% increase from last year.

Discussion ensued.

Impact of Chronic Absenteeism

Dr. Robert Sahli, Associate Superintendent, introduced Uve Dahmen, Coordinator, Assessment Research & Evaluation; Mark Dawson, Director, Educational Services, Area 1; and Peter Lampert, Director, Educational Services, Area 2. Mr. Dahmen presented the data summary and the performance differences impacted by chronic absenteeism.

Student Representative Gardea spoke about the McNair Soar Program, and asked if the report included students who missed due to lack of transportation. He commented about student safety, and would like the district to take actions to make students feel safer.

Student Representative Sweetman spoke about how important the teacher's role and actions are in the classroom to help make students feel welcome.

Proposed Accounting Reorganization

Proposed Revisions to Board Bylaws

Superintendent Young presented the proposed revisions to various Board Bylaws for consideration.

Dr. Bal questioned the statement in Board Bylaw 9100 that the Lodi USD Superintendent is the Secretary of the Board, not the Secretary on the Board.

No public comments were received.

Proposed Revision to Board Rule 1312.2

Dr. Sahli presented and explained the process of the proposed 5-step process when following the Board Rule for Complaints Concerning Instructional Resources.

Mr. Porter stated his concern for Step 3, Superintendent Determination. Discussion ensued.

President Nava requested staff to review the Board Rule and if needed, make any changes.
