Our school has events such as Back to School Night, Open House, Title I Parent Information Night, ELAC, Lunch on the Lawn and Honor Roll Assemblies to help increase parent involvement at our school. Parents are encouraged to view their students' classrooms, meet their teachers and learn about grading, classroom expectations and instructional strategies to be used. Emphasis will be placed on student work, learning and when homework is due. Our school also provides IEP, IST, 504 and Parent Conferences to keep parents informed on their students progress. Information for parents are either done by our Blackboard Connect messaging system, phone calls and emails and are translated in the languages that are needed. Students are also given paper copies of notices during school to present to parents. Information is also printed, translated and mailed home through our district office.

2.1 Involvement of Parents in the Title I Program

Students who are current 6th graders who will be incoming 7th graders from our feeder elementary schools will receive information about classes at our Open House. A brief presentation is given with all information regarding classes and electives. The presentations provide information about our STEM academy (Science, Technology, Engineering, Mathematics), ELAC, After School Intervention program, SSC and to increase parent involvement at IEP, IST 504 and parent Conferences. Our bulletins are sent home to our incoming 7th grade students and parents through our mailers, parent newsletters, blackboard connect calls and email messages. We also provide a Course Selection form along with the Course Catalog so students and parents can work with each other to pick classes for the school year.

Parents are offered the opportunity to view their students' classrooms, meet their teachers, and learn about grading, classroom expectations, and instructional strategies to be used. Emphasis will be placed on student work, learning, and when homework is due.

We increase parent involvement at our IEP, IST, 504, Parent Conferences, ELAC meetings, SSC (School Site Council) meetings, Back to School night, Open House, Music/Choir & Fine Arts Program, Lunch on the Lawn, game night and Parent/Guardian Orientation. We encourage our parents and guardians who are learning English to participate on committees. Participants work together to support students academically. ELAC (English Learners' Advisory Committee) have 5 meetings during the year so parents and guardians can have input in the site plan and monitor the students in the program. Phone calls are done by our Community Liaison to invite parents to the meetings. The policy is reviewed with parents and opportunities for input is provided at each event.

Teachers make weekly updates to their gradebook for parents and students to review online. Additionally, school provides grade reports during progress reports and quarter grades.
