RESOLUTION AUTHORIZING CONTRACT PURSUANT TO PUBLIC CONTRACT CODE SECTION 20118 (PIGGYBACK STATUTE)

WHEREAS, Lodi Unified School District requires the procurement of fresh hot pizza from an established vendor via and agreement; and

WHEREAS, Palm Springs Unified School District published an official notification inviting for fresh hot pizza, which were required to be submitted sealed and no later than 2:00 p.m. on May 25, 2022; and

WHEREAS, Domino's Pizza ("Vendor") was awarded the agreement to provide fresh hot pizza to Palm Springs Unified School District, on June 14, 2022 ("Piggyback Contract"); and

WHEREAS, the Piggyback Contract can be utilized by Lodi Unified School District in conjunction with Public Contract Code section 20118 which allows other public agencies, including the District, to obtain service from the Vendor pursuant to the same terms and conditions of the Piggyback Contract; and

WHEREAS, District staff researched the costs and terms to continue the Piggyback Contract and came to agreement with the local Domino's Pizza franchise to secure lower local franchise pricing and adhere to the terms and conditions of the Piggyback Contract.

WHEREAS, District staff believes the terms, conditions, and amended pricing are reasonable and that it would be in the best interests of the District to continue to utilize the Piggyback Contract to obtain fresh hot pizza from the Vendor.

THEREFORE BE IT RESOLVED that the Board of Education approves and authorizes the agreement with Domino's Pizza to provide fresh hot pizza to Lodi Unified School District

BE IT FURTHER RESOLVED that the Superintendent of the District, Chief Business Officer, and other officers of the District, and each of them individually, are hereby authorized and directed, for and in the name of and on behalf of the District, to execute and deliver any and all documents, to do any and all things, and take any and all actions that may be necessary or advisable, in their discretion, in order to complete the changes, and to effect the purposes of this Resolution. All actions heretofore taken by officers, employees, and agents of this district that are in conformity with the purposes and intent of this Resolution are hereby approved, confirmed, and ratified.
