Comments from Student Representatives

Mr. Joseph Gardea, McNair High School and Mr. Logan Sweetman, Tokay High School, presented reports from their respective schools.

Comments from Employee Representatives

Lisa Lennon-Wilkins, President, Lodi Education Association, explained that district and LEA negotiations are scheduled for Friday and invited Board members to attend. President Lennon-Wilkins honored the life and legacy of Lori Celiz by providing insight into Lori as a servant leader and highlighting her many accomplishments and attributes.

Comments from the Public

Michael Hunting, Systems Analyst, Technology Department, shared that Society for Creative Anachronism (SCA), a non-profit group that is an inclusive community pursuing research and re-creation of pre-seventeenth century skills, arts, combat, and culture will host an event at American Legion Park in Lodi on Saturday from 10:00 a.m. to 5:00 p.m. All are welcome.

Maggie Ellis, Teacher, reported that the situation with her daughter at Lodi High School has improved and announced that her daughter has received a scholarship to the University of Santa Barbara. She invited Board and staff to visit the co-teaching program at Delta Sierra Middle School.

Karen Minick, Teacher, Bear Creek High School, shared that the California Legislative Office published a report noting that costs in the state have risen by twenty percent since 2020. She asked that the district be responsible and fair when considering a cost-of-living adjustment to recruit and retain teachers.

Kelly Hansston, Teacher, Julia Morgan Elementary School, spoke of the value of relationships and explained that teachers work tirelessly to give their best to their students and in return they would like to see some movement by the district in negotiations.

Mrs. Macfarlane stated a Board report spoke of needs for the two Lodi schools and then the resolution comes back for only one school. She noted the Board wants to see movement on all schools, equally.

Mr. Porter asked why the position was a vice principal and not an assistant principal. Mr. Young clarified that the assistant principal position is only utilized at the high school level.

Mr. Porter questioned the history of a vice principal position at the two sites and asked about funding.

Mr. Young noted that this position was approved with the reorganization plan.

Mr. Nava moved, Mrs. Macfarlane seconded, and the Board voted unanimously to approve Item OAI-4 Approval of a Job Description for Alternative Program Vice Principal.

Nondiscrimination/Harassment

Robert Sahli, Associate Superintendent, noted that the revisions and deletions were warranted due to changes in the California Education Code, Federal Program Monitoring recommendations, and California School Boards Association's recommended updates. He clarified that some of the deletions are because the information is now contained in another policy and/or rule.

Student Representative Gardea noted that he was glad the district was modernizing policies.

Ms. Alexander voiced concerns with the updates to policies 5131.2 and 5145.9, as the original policies included discipline for bullying behavior and harassment.

Superintendent's Report

Superintendent Young commented how proud he was of everyone that rallied to assist the Ansel Adams School community in the wake of the news of Lori Celiz's passing. Everyone from the principal, counselors, mental health therapists, substitutes, and others who were a testament to the amazing people in our district.

He commented that artificial intelligence is an interesting new reality and noted we have an opportunity for parents to utilize it as a tool; parents are the next level to bring into the loop. He issued an invitation to the annual Lodi USD/GOT Kids Spring Art Show that is happening on Saturday, April 27 at the district office.

Comments from Board Members

Mr. Porter shared his experience of visiting Heritage Elementary School on April 11th to read to Carla Price's 4th grade students. He was able to meet with Principal David Gutierrez-Cabrera, speak to teachers, and to view, firsthand, the day-to-day life of an elementary teacher. He gave kudos to Mrs. Price for 30 years of quality work.

Mr. Nava shared that he and Mr. Knackstedt presented awards at the Elementary Math Tournament.

Mr. Knackstedt also commented about the Elementary Math Tournament and the achievements of the winners. He thanked Superintendent Young for the comments about district staff rising to the occasion when needed.

Ms. Alexander commented that she would like to hear updates and feedback from teachers about the various programs the Board has approved through contracts; programs such as Sweat III, AVID Ignite Conference, PLCs, and others. She attended the San Joaquin County Office of Education's awards dinner that recognized counselors, teachers, and classified employees. Ms. Alexander summed up that our hearts are heavy this week.

Mr. Stroh visited four schools last week and will be returning to Live Oak Elementary School tomorrow. When he visited Lockeford K-8 he was able to observe the involvement and collaboration of the Lockeford community, including groups like the Lockeford Lion's Club, with the school site.

Dr. Bal attended the Collective Concert at Bear Creek High School and commented on the talented student musicians that took part. She encouraged continued support of district programs for art and music.

Student Representative Gardea thanked Board for the respect and attention given to him during his year of service as a representative. He hopes to continue his participation as a community member.
