## RESOLUTION 2024-62 AWARD OF CONTRACT AND AUTHORIZATION TO BEGIN WORK FOR THE J.A.E.S.C. ROOFING REPLACEMENT PROJECT NO. 3213-4416-11

WHEREAS, on March 19, 2024, Resolution 2024-28, the Board of Education of Lodi Unified School District approved authorizing staff to advertise and receive bids for the work required for the J.A.E.S.C. Roofing Replacement Project. Scope of work consists of contractor purchasing, installing, and include all labor, materials, equipment, calculations, drawings, services, supervision, and transportation necessary for the roofing replacement of J.A.E.S.C. Roofing Replacement Project No. 3213-4416-11.

WHEREAS, that the Board of Education of the Lodi Unified School District hereby identifies Roofing Constructors Inc. dba Western Roofing Service of San Leandro, California to be the lowest and best respondent; and

**NOW, BE IT FURTHER RESOLVED** approval of this Resolution certifies the Award of Contract and Authorization to Begin Work for the J.A.E.S.C. Roofing Replacement Project, establishing a final contract award in the amount of \$798,930, which includes a \$72,630.00 District controlled construction allowance; and

**BE IT FURTHER RESOLVED** that all other bids are hereby rejected.

**BE IT FURTHER RESOLVED** that the Superintendent of the District, the Chief Business Officer, and other officers of the District, and each of them individually, are hereby authorized and directed, for and in the name of and on behalf of the District, to execute and deliver any and all documents, to do any and all things, and take any and all actions that may be necessary or advisable, in their discretion, in order to complete the changes, and to effect the purposes of this Resolution. All actions heretofore taken by officers, employees, and agents of this District that are in conformity with the purposes and intent of this Resolution are hereby approved, confirmed, and ratified.
