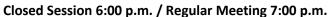


# MINUTES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION

Board thanked Dr. Crocker for a job well done and Mr. Young confirmed that Board would like the item to return for action at the next meeting.

## **Board Member Advisory Reports**

Mrs. Macfarlane and Mr. Stroh spoke about the recent Joe Serna Jr. Charter School Advisory Committee meeting, stating the discussion was about the Spanish 1 and Spanish 2 courses of study.

Mr. Stroh and Mr. Porter spoke about the City of Lodi 2x2 Committee meeting, stating the discussions were on park fees and usage; expansion of the city; electric buses; niche sports centers; and about Lodi becoming a Blue Zone Project.

#### Comments from the Public

Bill Yates, Teacher, Sutherland Elementary School, spoke about the enrollment process for Extended School Year.

Stayci Loya-Barnhart, Typist Clerk, Lodi High School, spoke about the job responsibilities of the athletic typist clerks and requested they be reclassified as athletic administrative secretaries.

Patricia Ramos, Teacher, Heritage Elementary School, stated that teachers should receive a higher cost of living adjustment.

## **Comments from Employee Group Representatives**

Lisa Lennon-Wilkins, President, Lodi Education Association, stated that LEA members are feeling frustrated about the slow pace of bargaining. She stated that LEA leadership members are visiting sites to get feedback, and teachers are reporting health and safety issues, stating there is a lack of custodial care and head lice breakouts.

Rodrigo Contreras, President, California School Employees Association (CSEA), Lodi Chapter #77, spoke about the cleanliness of school sites because of the lack of custodians. He requested outdated CSEA job descriptions be reviewed and updated.

### **Comments from Board Members**

Mr. Nava congratulated the women's Tokay High School wrestling team for winning the championships and requested a report on custodian shortage.

Mrs. Lenderman requested a special education report showing vacancies.

Mrs. Macfarlane thanked Mrs. Church for the work she does in negotiations and then stated that COLA in 1.07%.

Ms. Alexander spoke about attending the NorCal Science Festival and reading at Leroy Nichols Elementary School for Read Across America.
