**NOW, THEREFORE, BE IT RESOLVED,** approval of this Resolution certifies the Award of Contract and Authorization to Begin Work for the Bear Creek High School Repair and Refinish Gym Floor Project establishing a final contract award amount of \$104,280.00. This final amount includes a 10 percent district-controlled construction allowance; and

**BE IT FURTHER RESOLVED**, that all other bids are hereby rejected.
