# Title I School-Level Parent and family Engagement Policy

Lawrence Elementary has developed a written Title 1 parent and family engagement policy with input from Title 1 parents. The school site annually involves parents in the joint development and agreement of the policy, which is reviewed as a part of the the Single Plan for Student Achievement (SPSA) and through the School Site Council (SSC) and English Learner Advisory Committee (ELAC). The policy describes the means for carrying out the following Title 1 parent and family engagement requirements.

#### 2.1 Involvement of Parents in the Title I Program

An annual Title 1 information meeting is held in August, as a part of Back to School night.

Parent, committee meetings, and conferences are held throughout the school year and offered on a flexible schedule to assist parents.

The School Site Council (SSC), and School Leadership Team review the Lawrence Parent and Family Engagement Policy annually. The Lawrence Elementary Title 1 program is reviewed annually as a part of the annual review of the SPSA.

Lawrence communicates regularly with parents about the Title 1 program through fliers, newsletters, text, email, Back to School Night, School Site Council, and the English Learner Advisory Committee (ELAC).

ii. A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging state academic standards. (20 U.S.C. § 6318[c][4][B])

At Back to School Night, teachers review the grade level curriculum, course objectives, and grade-level expectations to support a high quality educational experience for each student. At parent-teacher conferences, assessment information on student academic progress and grade level standards are shared and discussed with parents. Teachers review student progress in relation to the state standards; including curriculum and data reporting for state and local assessments. Interventions in reading, ELA, and mathematics are discussed for students not meeting grade level standards.

iii. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. (20 U.S.C. § 6318[c][4][C])

Parent-teacher conferences are held annually and more regularly upon request of the parent and/or teacher. The school encourages parent engagement, and provides opportunities for parents to participate, give voice, and make recommendations relating to the education of their children. These opportunities are provided through conferences, meetings, at the request of parent(s), Back to School Nights, monthly parent/student calendar & survey questions, the SSC, and the ELAC.

e) If the schoolwide program plan is not satisfactory to the parents of participating children, the school submits any parent comments on the plan when the school makes the plan available to the local educational agency (LEA). (20 U.S.C. § 6318[c][5])

Lawrence elementary will submit all written documentation of parent comments on the plan that demonstrate that the program is not satisfactory to the LEA.

### 2.2 Building Capacity for Involvement

Lawrence Elementary School engages Title I parents in meaningful interactions with the school. Lawrence supports a partnership among staff, parents, and the community to improve student academic achievement. Parent information meetings, Back to School Night, informal parent requests, parent trainings, and through ongoing communication between school and home. The school communicates regularly with parents regarding student academic progress through progress reports, sharing assessments results, and providing information on how parents can best support their children in making academic growth. Progress reports and assessment results are sent home quarterly, and parent-teacher conferences assist parents in building capacity for involvement.

b) The school provides materials and training to help parents work with their children to improve their children's achievement, as appropriate, to foster parental involvement. (20 U.S.C. § 6318[e][2])

Lawrence Elementary provides trainings and informational meetings throughout the year to support parents in supporting their children's education. This may include but is not limited to activities such as: Adult English classes, Parenting Classes, and Health Informational Meetings.

Staff is educated in the value of parent contributions and partnerships at various staff meetings throughout the year. Staff collaborate regularly to discuss best practices and strategies to boost parent engagement in their child's educational program.

Parent involvement programs are integrated with various community resources, such as the local food bank, law enforcement agencies and social services.

The school provides a Spanish-speaking community liaison who assists the Spanish-speaking community at our school site. School information, including communication about the Title 1 program, will be distributed in the languages spoken by the families of students in the school as outlined in law.

The SPSA includes a goal dedicated to parent involvement. Strategies for engaging and involving parents within the SPSA are based on parent feedback and parent survey results.

All parents, including parents with limited English proficiency are provided information in an understandable format as outlined in the law. At Lawrence elementary, written communications to parents are translated into Spanish. The

school Community Liaison and Bilingual Paraeducators provide translation support to ensure parents are provided with information in an understandable format.

Lawrence elementary distributes parents and family members of Title 1 students a school-parent compact. The compact is jointly developed by parents, and describes how parents, students, and staff will share in the responsibility of ensuring student academic achievement. The Lawrence Elementary School mission statement: We believe in a safe school climate in which critical thinking and lifelong learning are emphasized, developed, and nurtured for students and staff alike. This includes the expectation of high standards for all students, allows for risk taking, and results in confident, caring, and productive individuals who strive for excellence in all that they do. We also support and respect cultural diversity of all types as well as students with a variety of special needs. Lawrence is committed to providing a high-quality curriculum and instruction on a daily basis which is made up of district adopted materials. Our school-wide emphasis is to focus on successful, effective programs for all students and a positive, cooperative effort between home, school, and the community.

Lawrence Elementary teachers discuss the School-Parent Compact as it relates to each student's achievement annually during parent/teacher conferences.

At Lawrence Elementary School progress reports are sent at the mid-point of each quarter to parents. Student assessment results and report cards are sent quarterly to parents, and parent conferences and meetings are held at a minimum annually to discuss student progress. Upon teacher and/or parent request more frequent parent-teacher conferences are held to discuss student progress.
