WHEREAS, one (1) bid was received at 2:00 pm. on March 29, 2024 at the Lodi Unified Maintenance & Operations Facility, 880 N. Guild Ave. in Lodi, Ca. The lowest bidder was RJ Inc. dba RJ Commercial Flooring Company of Modesto, California, in the full amount of \$846,918.60; and

WHEREAS, that the Board of Education of the Lodi Unified School District hereby identifies RJ Inc. dba RJ Commercial Flooring Company, of Modesto, California to be the lowest and best respondent; and

NOW, BE IT FURTHER RESOLVED approval of this Resolution certifies the Award of Contract and Authorization to Begin Work for the Phase 2 Flooring Replacement at Multiple School Sites (Re-Bid) Project, establishing a final contract award in the amount of \$846,918.60, which includes a \$76,992.60 District controlled construction allowance; and

BE IT FURTHER RESOLVED that all other bids are hereby rejected.

BE IT FURTHER RESOLVED that the Superintendent of the District, the Chief Business Officer, and other officers of the District, and each of them individually, are hereby authorized and directed, for and in the name of and on behalf of the District, to execute and deliver any and all documents, to do any and all things, and take any and all actions that may be necessary or advisable, in their discretion, in order to complete the changes, and to effect the purposes of this Resolution. All actions heretofore taken by officers, employees, and agents of this District that are in conformity with the purposes and intent of this Resolution are hereby approved, confirmed, and ratified.
