Lodi Middle School has developed a written Title I parental involvement policy with input from Title I parents. Parent meetings and conferences are held throughout the school year and are offered on a flexible schedule to assist parents.

The Lodi Middle Parental Involvement Policy and the School-Parent Compact are reviewed annually by the School Site Council (SSC), English Language Advisory Committee (ELAC) and school Leadership Team. The Title 1 program is reviewed as part of an annual review with all groups. The parent and staff input is vital in revising programs.

A monthly parent newsletter, Back To School Night, monthly School Site Council meetings, and quarterly ELAC meetings are held to inform parents about the Title I programs and involvement activities at Lodi Middle School. The newsletter is distributed through:

The curricula offered at Lodi Middle School are Board approved. Curriculum materials are based on state academic standards and are used with fidelity. Curriculum in subjects is assessed in accordance with the curriculum programs and through district benchmark assessments. Data from these assessments is used to drive instruction. A school-wide Parent Conference Night is held in the second quarter and requested parent conferences are offered throughout the year. Student progress in relation to state and local standards is explained to parents including grade-level expectations for proficiency and interventions available to students in subject areas needed.

Lodi Middle School has an open-door policy for parents to meet with teachers, staff, and administration. The school's responsibility is to provide high-quality curriculum and instruction. The parents' responsibility to support their children's learning.

Lodi Middle School provides 7th grade Orientation Day, Back To School Night, Parent Conference Night, and access to student grades.
