Turner Academy has developed a written Title 1 parent and family engagement policy with input from Title 1 parents. The school site annually involves parents in the joint development and agreement of the policy, which is reviewed as part of the Single Plan for Student Achievement (SPSA) and through site advisory groups, e.g. School Site Council (SSC). The policy has been distributed to parents. 2.1 Involvement of Parents in the Title I Program

Information about Title 1 is given at our annual Back to School Night. Every August, the annual meeting is held and parents are given the Title 1 information at this time.

A flexible number of meetings will be held at various times based on parent need . A remote option is given to accommodate parents who are not able to physically come to our school for a meeting because of various reasons.

Turner Academy provides parents of participating children with Back to School Nights and School Site Council.

At parent-teacher conferences, assessment information on student academic progress and grade level standards are shared with parents. Student progress in relation to state and local standards will be explained to parents including the curriculum being used, grade-level expectations for proficiency , data reporting for state and local assessments and available interventions in reading, ELA, and mathematics for students needing assistance. Student academic progress is also measured through student IEPs and and progress monitoring.

- iii. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible. (20 U.S.C. § 6318[c][4][C])

Opportunities for regular meetings when requested by parents are offered through formal parent-teacher conferences, informal requests by parent, meetings, Back to school Nights, Open House, SSC, and IEP's.

2.2 Building Capacity for Involvement

At staff, meetings and teacher meetings, strategies to enhance parent involvement are discussed and integrated into our educational program.

1. The ways in which each parent will be responsible for supporting their children: participation through the educational process; parents support their child's learning by assisting with skills learned at school and ensuring students are completing any work that is sent home.

2. Positive use of extracurricular time is discussed during formal and informal conferences. Parent support is given regularly through our school staff to ensure that parents have skills and strategies to work with their child at home. Turner Academy will provide resources for parents that outline strategies to work with their children at home.

The parent compact will be developed and finalized through the SSC. Throughout the school year, the compact is referred to with the purpose of ensuring that Turner Academy is following what has been agreed upon.

Parents receive daily communication reports on their child's progress. Parents also receive progress on goals and assessments quarterly through the IEP process.

Staff is available by phone, email, or walk in to the school. Parents can request to observe students in the classroom.
