**AUTHORIZING CERTAIN EMPLOYEES TO SIGN ORDERS DRAWN ON
SCHOOL DISTRICT FUNDS**

WHEREAS, Education Code sections 42632 and 42633 authorize the Board of Education to delegate its authority to sign orders drawn on District funds to officers or employees of the district; and

WHEREAS, the Board of Education of the Lodi Unified School District of San Joaquin County deems it necessary to so delegate its authority to the employees hereinafter named;

NOW, THEREFORE, BE IT RESOLVED, that the following employees be, and they hereby are, appointed the authorized agents for the Board of Education and are empowered, authorized, and directed to sign all orders for payroll and/or payments to vendors on behalf of the Lodi Unified School District:

BE IT FURTHER RESOLVED that the verifications of each of said employee's signature, including verified copies of their respective facsimile signatures, be attached hereto and that copies of this resolution and attached verifications, duly certified by the Clerk of the Board of Education, be sent to the County Counsel, the County Superintendent of Schools, and the Auditor-Controller of San Joaquin County.

BE IT FURTHER RESOLVED that only those employees listed in this resolution, and no others, be authorized to sign such orders. All prior authorization issued by this Board of Education are hereby superseded and rendered without effect.
