The school needs will be addressed through an addition of a Community Liaison. Lakewood Elementary professional development will be centered on three core areas to include instruction, community, and accountability to ensure all students are provided with the opportunity to work towards mastery of grade-level standards in a safe, engaging and nurturing community.

Our implementation of Professional Development with our CORE Consultant and Academic Conferences, providing afterschool intervention opportunities for students below grade level standards, and implementing Positive Behavioral Interventions and Supports (PBIS), rewarding student attendance weekly and parent incentives quarterly, were effective and showed an increase of student attendance and performance.
