They could all begin the program taking two semesters of the Life Management class in order to earn their 10 credits that they need for an elective space. There is still a need for credit recovery after school too but this would serve the seniors first and the juniors second as is currently in place. Part of the challenge we are experiencing at my site is identifying students who need CR and actually having them show up. Counselors need help to identify students failing freshman and sophomore level courses. These students should be flagged as at-risk much earlier. I have a student currently in CR who is 100 credits behind as a junior. Earlier this year, I had a senior who needed 9 classes. If CR is during the school day and is also open to grade improvement we can help students graduate and improve our A-G numbers. It is a win-win.
