Comments from the Public

Alisa Moland, Parent, Ronald E. McNair High School, stated she has addressed the Board previously; however, she has yet to resolve an issue pertaining to her daughter, and is still awaiting a response from District staff. She wished Superintendent Washer well on her pending retirement.

Alayssia Townsell, Ronald McNair Graduate and Former Student Board Representative (2018-2019), stated she was glad to see the Board Members, staff, Dr. Washer, and Mr. Freitas. Ms. Townsell apprised the Board that she is graduating this week from University of California, Los Angeles with a B.A. in Public Affairs. She will soon

start an internship at the Los Angeles City Hall and has future plans to pursue law school and would like to also pursue a PhD. in board policy. Ms. Townsell wished Dr. Washer well on her retirement.

Ron Freitas, San Joaquin County District Attorney and Former Lodi USD School Board Member, presented a video clip titled One Pill Can Kill. The video featured information of the dangers of Fentanyl. Mr. Freitas reported that five hundred Californians die each month from Fentanyl overdoses. Six out of ten pills contain a lethal dose and fake pills are made to look like candy to attract children. He would like to conduct a rally at an upcoming District event to share the message about the dangers of Fentanyl. Mr. Freitas also shared information about an upcoming youth leadership academy and noted that additional information and applications can be found on the San Joaquin County District Attorney website.
