Other Action Items

Item OAI-1 Local Control and Accountability Plan (LCAP)

Dr. Sahli distributed copies and briefly went over the Lodi USD Local Priority Indicator Data Review for the California School Dashboard. He explained that the Local Priority Indicator Data is how the state determines we are on track to address growth areas and how it relates to the LCAP, which is our budget to achieve these goals.

Item OAI-2 2023-24 Budget Adoption

Adina Andris, Director of Budgets, reviewed the Budget Adoption and gave the 2023-2024 Budget Revenues at \$458 million; 2023-2024 Budget Expenditures at \$474 million; ADA & Enrollment Projections; and Special Education Expenditure Trends. She explained that the ESSER III is a reimbursement grant and that negative cash balances are an immediate claim on the general fund balances. Ms. Andris stated that COLA is included in the revenues and expenditures and the Declining Enrollment Commitment is \$90 million.

Mr. Knackstedt asked if Ms. Andris had any big concerns.

Ms. Andris stated that the District will see the impacts of the declining enrollment in the 2025-2026 school year.

Mr. Porter moved, Mr. Stroh seconded, and the Board voted unanimously to approve Item OAI-2 2023-24 Budget Adoption.

Item OAI-3 Approval of the Primary Mascot Logo for Lakewood Elementary School

Mr. Young presented the new Lakewood Elementary School logo for Board consideration.

Item OAI-8 Ratification/Approval of Amendments to Superintendent's Employment Contract

Mr. Nava read the proposed amendments to the Superintendent's employment contract with the District containing the following compensation provisions:

- 1. The Superintendent's base salary shall be increased from \$265,000 to \$290,000 effective July 1, 2023.
- 2. The Superintendent's base salary shall be increased by \$10,000 upon his completion of an Education Doctorate degree program.
- 3. The Superintendent shall receive a 3% step increase to his base salary effective July 1st in 2024 and 2025.
- 4. The Superintendent's automobile allowance will be increased from \$750/month to \$1,000/month.
- 5. The contract provision providing that the Board of Education may terminate the Employment Contract of the Superintendent without cause in section 12(d) has the length of the maximum allowable payoff period reduced from 18 months of salary to 12 months of salary.

Overview and Analysis of the K-2 Early Reading Program

Mr. Young, Associate Superintendent, introduced Susan Petersen, Director of Education, Area 1, who reported on efforts to increase academic literacy achievement and shared data on the progress toward meeting the Board goal of students reading by the end of third grade.

Mr. Porter and Mr. Stroh thanked staff for the report and hard work for the program.

UC/CSU A-G Completion Rate Improvement

Robert Sahli, Associate Superintendent, introduced Aisha Brice, Program Coordinator, Positive School Climate, and Cindy Mettler, AVID Instructional Coach, who presented a two-pronged plan in an effort to improve the number of students who successfully meet the UC/CSU A-G eligibility requirements. They explained one effort provides for "D" grade improvement opportunities and one effort to provide A-G additional course offerings.

Ms. Alexander asked how long the grant is and if science will be included in the future.

Dr. Sahli stated it is a five-year grant and Mrs. Mettler stated that offering science is tricky because of the lab component but hopes to explore that as an option in the future.

Mr. Porter asked what the motivation is for the students to participate.

Dr. Brice stated the motivation is to provide opportunity for students to become A-G eligible, which opens more possibilities when applying to colleges.
