## **Comments from Employee Representatives**

Lisa Lennon-Wilkins, President, Lodi Education Association (LEA), spoke about concerns with the 2023/2024 LEA agreement, certificated substitute pay rate, and her frustrations about more district office jobs being created. She questioned the details of the book review committee being disbanded and commented on the new process for comments from the public.

Desiree Wise, President, California School Employees Association, Lodi Chapter #77, stated she is looking forward to bargaining starting for the new school year and that the library media assistants are attending tonight's meeting to discuss the impacts to their jobs with the Fiscal Services and Operations Department proposed restructure.

#### **Comments from the Public**

President Knackstedt announced that in order to provide equal access, public comment slips will be randomly selected, rather than heard in the order received. He stated slips will be accepted until the public comment time period begins, and a constituent's time cannot be deferred to another speaker.

Hollie Joy Mueller, Community Member/Retired Teacher, spoke about limiting access to sexually explicit books to safeguard students.

Wende Berry, Community Member, spoke about the revision of policy 1312.2 and how she feels the recent district correspondence regarding the review committee does not address the proper procedure for handling complaints and book challenges. She requested the Board revise policy 1312.2 and referenced a document that was handed to Board titled "Proposed Statement and Motion to Revise."

Lisa McBride, Community Member, spoke about how students should have equal access to age-appropriate materials. She requested the Board revise policy 1312.2.

Terry Welch, Community Member, stated that her two children graduated from Lodi High and complimented the Lodi High staff, thanking them for a wonderful experience. She continued to read from the same speech as the two previous speakers, requesting changes to be made to policy 1312.2.

Pete Rodriquez, Community Member, spoke about his issues with what he feels is being taught in the classroom and would like for LGBQ sexually explicit books to be restricted from school libraries.

#### **Student Mobile Device Use in Schools**

Mark Dawson, Area 1 Director, stated that Assembly Bill 3216 was proposed in February of this year and would require school districts to limit or prohibit the use of smartphones. He noted that the assembly bill effective date was amended from July of 2025 to July of 2026. Mr. Dawson spoke about some resolutions that other districts are implementing to restrict the use of cell phones. He stated that staff is planning on gathering data from Millswood Middle School and feedback from school sites, families, staff, and students to see what our policy might look like.

Mr. Nava and Mr. Porter spoke about their support in the matter and look forward to receiving more information as the data is gathered.
