#### **Services Provided by Instructional Coaches**

#### **Comments from Employee Group Representatives**

Desiree Wise, President, California School Employees, Lodi Chapter #77, spoke about the increase in health care rates and commented on the unrepresented employee groups putting the cap on the salary in 2005/2006.

Valerie McFee, Confidential Unit Member, stated the employees who voted to add the cap to the salary in 2005/2006 are no longer in the district and was happy that it came to an end when Board voted to implement a cap for the confidential group in 2022.

Lisa Lennon-Wilkins, President, Lodi Education Association, spoke about the unrepresented groups cap being placed on the salary in 2005/2006. She commented on Mr. Robison, a parent who spoke during public comments, stating he was upset that the Board spent lots of time debating \$12 million on sports fields and no time on needs for special education students. Ms. Lennon-Wilkins stated LEA is concerned about the negative effects on students if Lodi USD is unable to recruit and retain teachers.
